Research Interests

My research concerns the production of online public goods by interorganizational actors. I am particularly interested in the social and structural tensions found in non-market contexts where these online public goods, which allow organizational actors to coordinate, share, learn, network, etc. (e.g., online social networks, wikis, communities of practice), are collectively managed by organizational actors. Thus, my work is informed by theories of collective action and social networks, and extends from the assumption that individuals (and systems) have the capacity to learn and adapt.
